- 1) Hourly rate, price per hour or part thereof. Payment shall be charged for at least one hour, and each hour commenced shall be charged as a full hour.
- 2) If case processing is required, an hourly rate or part thereof will be charged.
- 3) NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.
- 4) No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.
- 5) Where several documents are issued together to the citizen, a total fee of DKK 200 (2,070 INR) shall be charged.
- 6) Provided the request for VAT refund comprises several separate purchases, a fee of DKK 200 (2,070 INR) shall be charged per statement.
- 7) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,355 (24,400 INR) shall be charged for the first passport and DKK 1,010 (10,470 INR) for subsequent passports.
- 8) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,365 (34,870 INR) shall be charged for the first passport and DKK 1,010 (10,470 INR) for subsequent passports.
